- Kennels (noncommercial or commercial) are **not permitted** in any of the following zoning districts: R-1, R-3, R-4 and R-5.
 - Kennels are permitted in the B-2 and A-2 zoning districts, provided that the applicant has a minimum of five acres, can locate the kennel at least two hundred (200) feet from a property line, that the use is not objectionable by reason of odor, bright lights or noise..
 - Kennel Definition is located in Bath County Land Use Regulations Section 302.118
 - Commercial kennels are permitted with a Conditional Use Permit approved by the Planning Commission and Board of Zoning Appeals in the R-2 zoning district, provided that a minimum of five (5) acres is required the owner can locate the kennel at least two hundred (200) feet of a property line, that the use is not objectionable by reason of odor, bright lights, or noise.
 - Certification from Animal Control must be obtained prior to issuance of kennel license.
 - The expiration date on the rabies certificate is November 1 of the license year.
 - If the certificate is expired, the owner must obtain a new rabies certification prior to issuance of license.
 - It is unlawful to own a dog older than four months unless the dog is currently licensed.
 - All applications are reviewed by Bath County Animal Control and may be deemed invalid if the kennel does not meet the standards as set forth by Bath County and Virginia State Law.
